COVENANT NOT TO SUE, RELEASE, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

This Agreement is entered into as a condition of and a part of the consideration for the South Central Llama Association (also known as "SCLA"), and its officers, directors, members, employees, agents and owners, agreeing to permit me/us to participate in the SCLA Youth Championship Show held on February 20, 2010.

I/we understand and acknowledge that any involvement with llamas can be hazardous; that llamas can be unpredictable and difficult to control; and that llama events and/or llama demonstrations are athletic events, and participating in such events or demonstrations involve numerous risks of injury.

It is further understood that other risks associated with participation or involvement in the SCLA Youth Championship Show include, but are not limited to, possibility of falls on the route or at the start or finish line, injuries caused by spectators or spectators' activities, injuries due to overexertion, the failure to properly police the event, and other risks and hazards associated with the handling and use of llamas.

It is further understood and agreed that basic first aid may be available but other emergency equipment and evacuation may not be present on-site during the SCLA Youth Championship Show. I/we voluntarily and expressly assume all risks and dangers of such involvement.

I/we and my/our heirs agree not to sue the South Central Llama Association or any of its officers, directors, members, employees, agents and owners and I/we and my/our heirs waive and release any and all claims arising out of such activities associated with the SCLA Youth Championship Show, in which any llama activity is conducted, including, but not limited to, any claims alleging negligence, breach of contract, strict liability, or otherwise, of the South Central Llama Association, or any of its officers, directors, members, employees, agents and owners.

This covenant not to sue, release, waiver of claims and indemnity agreement includes, but is not limited to, bodily injury, death, property damage, loss, contribution, indemnity, and any other claims which I/we and my/our heirs may have or ever have against the South Central Llama Association or any of its officers, members, employees, agents, and owners.

I/we and my/our heirs also agree to defend, indemnify, and hold harmless the South Central Llama Association or any of its officers, directors, members, employees, agents, and owners, involved from any expenses, damages, or judgments, including any legal expense, reasonable attorney's fees, claims for contribution or indemnification resulting from claims by third parties arising out of my/our activities mentioned above or the use of any property in relation to any of my/our activities, and if applicable, the claims of my/our heirs.

I/we also acknowledge and agree that I/we have or it is understood that it is our responsibility to obtain and keep in force sufficient insurance coverage (including, but not limited to, liability, health, life and llama mortality) to protect me/us from any expense, liability claims, or damages mentioned or included in the Agreement, and that whether or not I/we obtain such insurance and whether or not such insurance is sufficient, the provisions above shall be fully effective and enforceable and I/we will be bound and liable thereunder.
